

SILVER LAKE COUNTRY CLUB JUNIOR LEAGUE.
PARENT/GUARDIAN RELEASE AND WAIVER RELATED TO COVID-19

Child Name(s): _____ (collectively referred to hereinafter as “Child”)

I acknowledge that the novel coronavirus, COVID-19 (or any of its mutations, forms, derivatives, or other communicable diseases) (collectively referred to herein as “COVID-19”), has been declared a worldwide pandemic by the World Health Organization. I understand that COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, I acknowledge that Silver Lake Country Club, Inc. (“Silver Lake”) has put in place various policies and preventative measures to avoid the spread of COVID-19, including but not limited to, monitored spacing of tee times and golfing groups, required social distancing, required wearing of masks before and after play and recommended wearing of masks during play. I understand that my Child and I are required to fully comply with such policies and preventative measures, as well as all applicable requirements and guidance from the Centers for Disease Control, the Occupational Safety and Health Administration, the Illinois Department of Public Health, and/or a federal, state, or local government. However, Silver Lake cannot guarantee that my Child and/or I will not become infected with COVID-19. Further, I acknowledge that participation in the Silver Lake Country Club Junior League could increase my Child and my risk of contracting COVID-19.

LIABILITY RELEASE AND WAIVER RELATED TO COVID-19: I, the aforementioned minor Child’s parent or legal guardian, agree that my Child and my participation in the Silver Lake Country Club Junior League is entirely at my discretion and that my Child and I will abide by all rules, policies, and directives of Silver Lake related to COVID-19. I understand and acknowledge the COVID-19 related risks and dangers associated with my Child and/or my participation in the Silver Lake Country Club Junior League including, without limitation, the risk of becoming exposed to or infected by COVID-19 as a result of the actions, omissions, or negligence of myself and others, including, but not limited to, Silver Lake, Silver Lake Golf Club, Inc., Jodibe, Inc., their starters, instructors, observers, shareholders, directors, employees, agents, and other children and their families. In consideration of being allowed to participate in the Silver Lake Country Club Junior League, I voluntarily assume the risk that my Child and I may be exposed to or infected by COVID-19 at Silver Lake and that such exposure or infection may result in personal injury, illness, permanent disability, and death. To the greatest extent permissible under applicable law, I, for myself and on behalf of my Child and my heirs, assigns, personal representatives, and next of kin, DO HEREBY RELEASE, COVENANT NOT TO SUE, DISCHARGE, INDEMNIFY, DEFEND AND HOLD HARMLESS Silver Lake, Silver Lake Golf Club, Inc., Jodibe, Inc., their starters, instructors, observers, shareholders, directors, employees and agents for any COVID-19 related injuries (including, but not limited to, personal injury, disability, and death), including all liabilities, claims, actions, damages, costs or expenses of any kind (including without limitation attorneys’ fees and litigation expenses) arising out of or relating thereto, which may result from my Child and/or my participation at Silver Lake. In accordance with applicable law, I EXPRESSLY AND FREELY ASSUME ALL RISKS (known and unknown) AND RESPONSIBILITY FOR ANY DAMAGES, LIABILITIES, LOSSES OR EXPENSES (including without limitation attorneys’ fees and litigation expenses) related to COVID-19 which may result from my Child’s and/or my participation in the Silver Lake Country Club Junior League at or sponsored by Silver Lake or claims made by any third party. I understand and agree that this release includes any COVID-19 related injuries that result from the actions, omissions, or negligence of Silver Lake, Silver Lake Golf Club, Inc., Jodibe, Inc., its starters, instructors, observers, shareholders, directors, directors, employees, and/or other children and their families, whether arising from negligence or otherwise, and whether a COVID-19 infection occurs before, during, or after participation at Silver Lake. I agree that this release and waiver is intended to be as broad and inclusive as is permissible by the laws of the State of Illinois.

Medical Release: I hereby consent to the rendering of emergency first aid and other medical attention deemed necessary at the time of an injury or illness. I agree to hold Silver Lake, Silver Lake Golf Club, Inc., Jodibe, their starters, instructors, observers, shareholders, directors, employees and agents harmless for such first aid and medical attention and any related expenses. I further understand that I will be responsible for payment for any such first aid and/or medical attention. I agree that in the event that my Child or I test positive for or am diagnosed with COVID-19, I authorize a medical provider to provide Silver Lake with such information. I also acknowledge that, to the extent required by law, Silver Lake will maintain the confidentiality of health information; however, I voluntarily agree that Silver Lake may share certain COVID-19 related health information to employees and/or parents or guardians of other children in the interest of the health and safety of such employees and children and their families, if Silver Lake deems it necessary to do so.

Bound Parties/Governing Law/Jury/No Expiration/Time Limitations/Severability/Modification: I understand and agree the terms of this Release and Waiver are binding on my spouse, partner, family members, heirs, trustees, beneficiaries, representatives, relatives, successors, agents and assigns and I agree to all the terms and conditions of this Release and Waiver on my own behalf and on behalf of my minor Child for purposes of participation at Silver Lake. In the event of a dispute or enforcement of this Release and Waiver, I agree Illinois law applies, that all disputes surviving this Release and Waiver must be resolved exclusively by the state court in Cook County, Illinois, and I waive my right to a jury trial. I agree that this Release and Waiver does not expire and that any claims that are not subject to this Release and Waiver must be brought within one (1) year of the date accrued. If any provision of this Release and Waiver is deemed invalid or unenforceable, the remaining provisions shall be valid and enforceable to the fullest extent of the law. This Release and Waiver can only be modified in writing signed by Silver Lake and me.

Representation of Authority of Parent or Legal Guardian: I represent and warrant to Silver Lake that I am acting as parent or legally appointed guardian of the Child(ren) listed above and have the authority to sign this Release and Waiver.

I have read and fully understand the contents, meanings and impact of this Release and Waiver. I acknowledge that I do not need any further explanation of the consents. I understand by signing this document, I have given up substantial rights. I have voluntarily signed this Release and Waiver and agree to its terms.
